(a) The Maximum Ordering Limitation (MOL) for products and services ordered, delivered and accepted under this contract is **\$527,136**, increased with the exercise of options, as follows:

(b) The guaranteed minimum obligated by the Government under this contract is \$80,000.

(c) A total estimated cost as well as any fee, if any, will be negotiated for each task order and will be incorporated as a ceiling in the resultant task order. The Contractor shall comply with the provisions of 52.232-20 Limitation of Cost for fully funded task orders and 52.232-22 Limitation of Funds for incrementally funded task orders, issued hereunder.

F.6 DURATION OF CONTRACT PERIOD (MAR 1987) ALT 4 (JUN 1988)

The ordering period for this contract shall commence on the Date of Award and will expire **9/30/2013**. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. The term of the contract may be extended at the option of the Government for an additional two one-year options.
