
Dear Sir or Madam:

The Nuclear Regulatory Commission (NRC) issued a closeout letter in Reference 1 to Bulletin 2011-01, that requires minor clarification. On page 4 (part of 2.2.2 Question 3) the letter states "... The second response specifically states that the following items are included in the inventory: portable pump; portable power supply; hoses; communications equipment; nozzles; connectors and adapters; nitrogen bottles; tools; instruments; and firefighter turnout gear." The Entergy response to Question 3 (Reference 2) does not list firefighter turnout gear, but does list suits (rain gear with hoods, rubber boots and gloves). Notice of this administrative error is being docketed to avoid potential misunderstandings in the future and requires no response.
