**SUBJECT: TERMINATION OF NRC RADIOACTIVE MATERIALS LICENSE**

By letter and application dated June 27, 2012, you informed the U.S. Nuclear Regulatory Commission (NRC) that Geotechnical Services, Inc. changed named and ownership, and moved from the State of Nebraska to the State of Kansas. Because of the office changed from one state to another, and following licensing guidance, NRC license 26-26790-01 is hereby terminated and the NRC is simultaneously issuing a new license number 15-26790-01, which will be sent in a separate correspondence.

NRC License No. 26-26790-01 authorized the use of licensed material at temporary job sites in NRC jurisdiction so there are no permanent storage facilities to decommission.

Enclosed is Amendment No. 03 to NRC License No. 26-26790-01 authorizing your license termination. An environmental assessment for this action is not required since this action is categorically excluded under 10 CFR 51.22(c)(20)(ii).
