SUBJECT: SUMMARY OF PUBLIC MEETINGS TO DISCUSS PROCESS FOR THE
PLANNED REVISION TO NUREG-0654/FEMA-REP-1, "CRITERIA FOR
PREPARATION AND EVALUATION OF RADIOLOGICAL EMERGENCY
RESPONSE PLANS AND PREPAREDNESS IN SUPPORT OF
NUCLEAR POWER PLANTS"

In preparation for the planned revision to guidance document NUREG-0654/FEMA-REP-1, "Criteria for Preparation and Evaluation of Radiological Emergency Response Plans and Preparedness in Support of Nuclear Power Plants," which can be found in the NRC Agencywide Documents Access and Management System (ADAMS) under ADAMS Accession No. ML040420012, the following Category 2 public meetings were held by the Nuclear Regulatory Commission (NRC) in coordination with the Federal Emergency Management Agency (FEMA):

The purpose of these meetings was to: (1) initiate a conversation with stakeholders and the public on the proposed revision process and initial changes to the document being considered by the NRC and FEMA; (2) provide an opportunity for the NRC and FEMA to answer questions about the planned revision; (3) provide an opportunity for representatives from various

stakeholder groups, as well as the public, to provide feedback on the planned revision, and (4) discuss future opportunities for stakeholder and public involvement.

During these public meetings, representatives listed below from FEMA, NRC, external stakeholder organizations, and members from non-governmental organizations (NGOs) were invited to speak as part of a panel on ideas for the revision process.

FEMA and NRC staff gave a general overview of why the revision was taking place, a projected timeline for the revision, and some general thoughts about what might be considered during the revision. Panel members representing external stakeholder groups and the NGOs provided further insights, based on their personal views and that of their constituents, which included discussions on what parts of the guidance document they believed should remain unchanged or updated, deleted, superseded, or revised in their entirety.

After comments by panel members representing FEMA, NRC, external stakeholder groups, and NGOs, the discussion was opened to comments and questions from the general public. There was a wide range of comments from the public, asking both FEMA and the NRC to look at certain areas of the document and how they believed the guidance could be improved. Two members of the public also provided slides, which can be found in ADAMS package ML12185A180.

After the public comment portion of the meeting concluded, FEMA and NRC staff elaborated on how the public could submit comments on the revision process. FEMA has opened up a docket on www.regulations.gov (Docket ID FEMA-2012-0026), which will remain open for public comments until the end of December 2012. FEMA and NRC staff encouraged external stakeholders, as well as members of the public, to post their thoughts and ideas on the revision to the guidance document. After the public comment period has closed and a draft has been created, there will be a series of public meetings to introduce the revised draft document. Once comments have been incorporated into the draft document, another public comment period will be considered for additional questions and comments.
