Pat -

Thanks very much for your help. SNL is currently preparing an updated subcontract to umd to cover their work under jon n6780. Since snl is very familiar with soarca and the related sensitivities (Shawn Burns is the SNL manager overseeing our contract), I'd prefer to defer to their contracting process to ensure adequate controls are in place (we discussed with Shawn yesterday and snl will be handling melcor access through the same process) - assuming this works for you. We'll make sure that the protection of this information is covered by snl before providing it to umd.

As far as the revisions in progress, to keep our work on schedule, I'd prefer to go with what exists now rather then waiting until April. I don't think the changes will have much of an impact of umd's contribution and we can double check this when the next revision is available (also, since umd will be working closely with snl, I think we can keep things on track).

Pat -

I know you are very busy, but Don Helton was looking for the green light to send some SOARCA related information to one of our SNL subcontractors (the University of Maryland) to support an ongoing project (N6780 – Advanced Level 2 PRA modeling). We will be looking at some scenarios that have similarities to what was done in SOARCA, and we'd like UMD to gain a better understanding of how SOARCA modeled certain events (e.g., PWR station blackout) and the results that were obtained. Although our calculations will not be done for the same purpose and the results will likely differ, we'd like to understand the starting point for SOARCA and be able to explain the specific modeling choices and results when our analysis diverge from what was done in SOARCA. So, with that background, and Don's email below, we'd like the green light to send UMD (currently under subcontract with SNL who in turn is under contract with the NRC) the Surry analysis appendix from the draft SOARCA nureg. No one we have spoken with in DSA has raised any objection to this (Charlie Tinkler, Richard Chang), but all deferred to getting the go-ahead from you. Let me know if you need any additional background information or if you'd like to meet on this...
