Peter,

This is in reference to your letter dated August 23, 2012 requesting an amendment of Nuclear Regulatory Commission License No. 06-00253-04. In order to continue our review, we will need the following additional information:

Item 1:

- a. Tatjana Ivanova, Ph.D. - Documentation from the University of Pennsylvania stating that Carmen Mesina is an authorized medical physicist on their license for HDR use.
- b. Robert F. Hoffman –
  1. NRC Form 313A(AMP) with the Part I, Section 3.c. and Part II completed by R. Hoffman's preceptor
  2. Documentation that the preceptor is an AMP on an NRC or Agreement State license as an AMP. If they are specifically listed on an NRC license, provide me the license number. If they are on a broad scope license at either an NRC or Agreement State, provide a copy of the permit issued by the Radiation Safety Committee authorizing them as an AMP and for what device. Finally, if they are specifically listed on an Agreement State license, provide a copy of the license.

Item 2:

- a. Documentation that they disposed sources have been transferred/received by an authorized recipient (shipping papers, etc.).
- b. Final leak tests of the disposed sources.
- c. For Item 6.D. of your license, do you want to adjust your possession limit?

Item 3:

- a. Northeast Regional Radiation Oncology will need to amend their license to add the cesium-137 sources.
- b. Hartford Hospital should get a copy of the NRRO amended license for their records.
- c. Leak test the sources prior to transfer and ship them to NRRO.
- d. Obtain documentation from NRRO that they have received the sources.

- e. Request an amendment to your license to remove the transferred sources.
