NOTICE AND ORDER
(Scheduling Prehearing Conference)

On September 18, 2012,¹ this Board notified the parties that it would convene an initial prehearing conference and oral argument regarding the petition² of the Prairie Island Indian Community (PIIC) to intervene in this 10 C.F.R. Part 72 licensing proceeding concerning the application of Northern States Power Company (Northern States) for renewal of its license to operate an Independent Spent Fuel Storage Installation (ISFSI) at the Prairie Island Nuclear Generating Plant in Red Wing, Minnesota.³

The prehearing conference will convene on Thursday, November 8, 2012 and continue on Friday, November 9, 2012 as necessary. The conference will take place in the Devitt Courtroom of the Warren E. Burger Federal Building & United States Courthouse, 316 North

Robert Street, in St. Paul, Minnesota. Proceedings will commence at 9:00 a.m. each day and will conclude no later than 5:00 p.m.

Oral argument will only be heard from the duly authorized representatives or counsel for PIIC, Northern States, and the NRC Staff who have entered an appearance pursuant to 10 C.F.R. § 2.314(b).⁴ The parties need not prepare opening statements; the Board will pose its questions to PIIC, Northern States, and the NRC Staff, addressing each of PIIC's seven proffered contentions and possibly PIIC's standing.
