SUBJECT: REQUEST FOR ADDITIONAL INFORMATION REGARDING PSI RESPONSE
DATED SEPTEMBER 4, 2012 TO NRC CONFIRMATORY ORDER (EA-10-161)

Dear Mr. Weiland:

The purpose of this letter is to acknowledge receipt of the letter from Professional Service Industries, Inc., (PSI) dated September 4, 2012 (letter), in response to the U.S. Nuclear Regulatory Commission's (NRC) Confirmatory Order (EA-10-161) dated August 18, 2011. We have completed our review of the letter and we have determined the need for additional information. Robert Gattone of my staff contacted John Thornton of your staff on October 3, 2012, to discuss the additional information that was needed and this request for additional information.

Item 6 of the Order requires PSI to assess the effectiveness of and adherence to the terms of the Order. The NRC identified the need for the following additional information as it pertains to compliance with Item 6 of the Order:

1. Item 4 of the Order required that PSI provide specific training to all Radiation Safety Officers (RSOs), radiographers, and radiographer's assistants. The letter does not specifically address PSI's assessment of its effectiveness of and adherence to Item 4 of the Order such as verification that the required training was provided. Therefore, please discuss your assessment of the effectiveness of and adherence to the terms of Item 4 of the Order.
2. Item 5 of the Order required that PSI conduct training of the RSOs on safety culture and the role and responsibility of the RSO to maintain an effective safety culture. The letter does not specifically address PSI's assessment of its effectiveness of and adherence to Item 5 such as verification that the RSOs received the required training. Therefore, please discuss your assessment of the effectiveness of and adherence to the terms of Item 5 of the Order.
3. Item 10 of the Order required PSI to notify NRC with a minimum of 8 days notice prior to entering NRC jurisdiction under reciprocity. The letter does not specifically address PSI's assessment of its effectiveness of and adherence to Item 10. Therefore, please discuss your assessment of the effectiveness of and adherence to the terms of Item 10 of the Order.

4. The letter does not specifically address PSI's assessment of its effectiveness of and adherence to Item 7 pertaining to security issues. Therefore, please discuss your assessment of the effectiveness of and adherence to the terms of Item 7 of the Order.

Please provide, in writing, the information requested above to me, Anne T. Boland, Director, Division of Nuclear Materials Safety, 2443 Warrenville Road, Lisle, Illinois 60532 within 30 days of the date of this letter.
