2) Physical Description

This shipment will consist of 63 drums of Uranium Ore Concentrate (U-308) in 1 x 20' ocean containers. The total weight of the shipment is 13,973.0 kgs of U-308.

3) Transportation and Route Schedule

The vessel is scheduled to sail from Adelaide on June 18, 2012. The ocean transportation from Adelaide to Seattle, WA USA will be the responsibility of Hapag Lloyd. The vessel will unload at Seattle, WA USA on or about July 13, 2012. The inland transportation from Seattle, WA to Blind River, ON will be the responsibility of RSB LOGISTIC SERVICES, INC.
