SUBJECT: SUMMARY OF TELEPHONE CONFERENCE CALL HELD ON OCTOBER 11, 2012 BETWEEN THE U.S. NUCLEAR REGULATORY COMMISSION AND ENTERGY NUCLEAR OPERATIONS, INC., CONCERNING THE INDIAN POINT LICENSE RENEWAL APPLICATION

The U.S. Nuclear Regulatory Commission (NRC) the staff and representatives of Entergy Nuclear Operations, Inc. (Entergy) held a telephone conference call on October 11, 2012, to discuss information pertaining to the NRC staff's ongoing review of the application for renewal of the operating licenses for Indian Point Nuclear Generating Unit Nos. 2 and 3 (IP2 and IP3). During the call, Entergy informed the NRC staff that it had recently identified piping that could be considered underground piping according to the definition in the Generic Aging Lessons Learned Report. The piping at issue is approximately ~~30-35~~ feet of each of the two service water headers piping (total of approximately 70 feet), and short sections of certain fuel oil piping, each located in a vault. Entergy ~~will be~~intends to submitting a letter clarifying the status of the piping and any associated impacts to the IP2 and IP3 license renewal application.
