Dear Mr. De Jesús Rozas:

This letter refers to your license amendment request dated September 7, 2012. You requested that David Rhoe be authorized as the Radiation Safety Officer (RSO) for your facility. You also stated, in your letter dated September 11, 2012, that all radioactive material (except depleted uranium) authorized by your NRC License No. 52-13471-01 is in storage. Currently, your license does not authorize medical use of brachytherapy sources. Prior to resuming medical use, you must submit an amendment request, and the request must be approved. Enclosed with this letter is the amended license.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
