

The purpose of this modification is to provide incremental funding in the amount of \$134,000.00. Therefore, the obligation amount has increased by \$134,000.00 from \$342,000.00 to \$476,000.00. In addition, clause 52.232-19 "Availability of Funds for the Next Fiscal Year", the first and third sentences are changed from \$342,000.00 to \$476,000.00. In addition, the NRC is exercising the option associated with Option period two. Therefore, the period of performance is extend to 12/1/2012-5/31/2013 and the ceiling is increased by \$191,147.00 from \$395,525.08 to \$586,672.08
