SUBJECT: SUMMARY OF WEEKLY CONFERENCE CALL MEETING TO DISCUSS OPEN ITEMS AND OUTSTANDING REQUESTS FOR ADDITIONAL INFORMATION RESPONSES RELATING TO DETROIT EDISON'S FERMI 3 COMBINED LICENSE APPLICATION

On Thursday, September 13, 2012, the U.S. Nuclear Regulatory Commission's (NRC) staff held a public conference call from 1:00 pm to 2:30 pm with members of Detroit Edison (DTE). The purpose of the conference call was to discuss the status of the remaining open items (OI) related to the Fermi 3 Combined License Application. A list of the agenda items, actions items discussed during the call and a list of attendees are below.

Agenda Items

1. Discussion related to recently submitted RAI response # 79 – SSI analysis - final date of RAI submittal, technical issues that warrant a year of analysis, what this means for the project regarding NRC resources, the ability to generate a schedule based on the RAI response. – DTE and the NRC staff discussed the content of RAI response 79 (ADAMS Accession number ML12254B017), which contains documentation for the date for a final response for RAI 79, and technical issues that warrant one year of analysis.
2. Proposed dates for public meeting for SSI discussion with the NRC staff – 1st week of October? The NRC staff is considering October 25th as a propose date to conduct an all day meeting with GEH on their SSI approach.
3. Submittal of FSAR markups for section 2.5.2 – what changes can the staff expect – DTE has taken an action item to get back to the NRC with a specific date in which they will provide the FSAR mark-up in response to RAI 77. During the call DTE asked NRC to discontinue their review of RAI 77 as there is a

possibility that this RAI will be revised and resubmitted. The staff has suspended its review of this RAI until further notice from DTE.

Meeting Action Items:

1. DTE to provide the NRC with a specific submittal date for FSAR mark-up related to RAI 77 (CEUS).
2. NRC staff to provide specific agenda items that they would like to discuss during the SSI public meeting to be held the end of October. – This item is complete. See attachment. In addition to this list the staff would like to request that the DTE Seismologist be present at the public meeting for questions related to RAI 77.
