Enclosed is Amendment No. 93 to your NRC Materials License No. 21-01333-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

In your letter dated July 18, 2012, you requested the deletion of a location of use on your license. We have reviewed the close-out surveys and other information submitted to support the release of the facility located at 25631 Little Mack Avenue, Suite 201, St. Clair Shores, Michigan. Based on this review, we have concluded that all licensable radioactive material has been removed from your facility and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Therefore, you may release this location for unrestricted use.

In addition, please note that we have revised Conditions No. 15 and 16 to reflect current standard wording for these conditions. Specifically, we have added the recordkeeping requirements to each of these conditions.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
