(b)(7)(C) HELPED US SET UP THE PARTICULARS AND REMAINED ON THE JOB FOR THE FIRST TWO SHOTS WE HAD FOUR SHOTS THAT NIGHT, EACH OF WHICH WAS APPROXIMATELY A 1 HOUR EXPOSURE WE WERE USING A 55 CURIE COBALT 60 SOURCE.

ON THE THIRD SHOT, AFTER (b)(7)(C) HAD LEFT, (b)(7)(C) AND I SET UP FOR THE THIRD SHOT.

(b)(7)(C)

(b)(7)(C) told me, before he cranked out the source, "you watch the barricade and I'm going to develop film." I positioned myself so I could see both sides of the barricaded area. After approximately one hour (b)(7)(C) came out the van and cranked the source back in. At no time during this exposure did anyone cross the barricade. During this third shot, I was alone outside in the barricaded area while (b)(7)(C) was in the van processing film.

For the fourth shot, we did the same thing. I maintained surveillance, by myself, while (b)(7)(C) developed film in the van. At the end of the shot, (b)(7)(C) did not come out of the van so I cranked the source back in and secured it. At that point I went to the back of the van, knocked and told (b)(7)(C) I had
