Dear Ms. Forster:

The purpose of this letter is to provide some clarification of our recently submitted Transfer of Control paperwork submitted as a result of our partnership with Bronson Methodist Hospital Kalamazoo, Michigan.

Effective June 1, 2012, Advanced Cardiac Healthcare entered into an agreement with Bronson Methodist Hospital to provide exclusive cardiology services here in Kalamazoo. As a result:

- 1) Our name has changed to Bronson Advanced Cardiac Healthcare.
- 2) We continue to provide services in our office but they are on a contractual basis - the services are billed as services provided by Bronson Methodist Hospital.
- 3) The equipment as well as the oversight of all aspects of the nuclear medicine program provided at our office remains under the same ownership and control as they were prior to June 1.
- 4) The staff who were involved prior to June 1, 2012 remain the staff who will oversee and conduct nuclear medicine tests in the facility after June 1.
- 5) The Radiation Safety Officer, Christopher Rogers, D.O. remains the Radiation Safety Officer for the site/facility.




