Dear Ms. Bishop:

Per your October 3, 2012 written request, please find additional information regarding the August 16, 2012 written notification of a name and stock ownership change which resulted in ThyssenKrupp Waupaca, Inc. changing its name to Waupaca Foundry, Inc.

Responses have been numbered to conform with the numbered requests in the October 3,2012 correspondence. Please also note that Waupaca Foundry was in receipt of NRC's request delivered by U.S. Post on October 22, 2012 and was therefore unable to respond by the requested October 19, 2012 deadline. As directed within the correspondence, any items which are not applicable are so stated.

1. Provide a complete description of the transaction (transfer of stocks or assets, or merger). Indicate whether the name has changed and include the new name. Include the name and telephone number of a licensee contact whom NRC may contact if more information is needed.

On May 15, 2012 ThyssenKrupp Budd Company entered into a stock purchase agreement with KPS Capital Partners, whereby all ThyssenKrupp Waupaca, Inc.'s stock would be sold to an affiliate of KPS Capital. The stock sale was completed on June 29, 2012 and all of the outstanding stock of ThyssenKrupp Waupaca, Inc. was sold and transferred to Waupaca Foundry Holdings, Inc. On the same date, ThyssenKrupp Waupaca, Inc. changed its name to Waupaca Foundry, Inc. in the state of Wisconsin and shortly thereafter in all other jurisdictions it is authorized to conduct business. Waupaca Foundry, Inc.'s name change is the most visible part of the transaction as both the ownership of individual facilities and the former ThyssenKrupp Waupaca management team is unchanged. The existing licensee contact of Bryant Esch (715-258-6674) remains the same and is also unchanged.

2. Describe any changes in personnel or duties that relate to the licensed program. Include training and experience for new personnel.

Not applicable. There have been no changes in personnel or duties related to the licensing program.

3. Describe any changes in the organization, location, facilities, equipment, or procedures that relate to the licensed program.

Not applicable. There have been no changes in organization, location, facilities, equipment or procedures related to the licensing program.

4. Describe the status of the surveillance program (surveys, wipe tests, quality control) at the present time and the expected status at the time that control is to be transferred.

There have been no changes in the status of the surveillance program or a time in which control will be transferred to a new party. Surveys, wipe tests and quality control continue to be performed as described in previous submittals and in compliance with the facility's Materials License.

5. Confirm that all records concerning the safe and effective decommissioning of the facility will be transferred to the transferee or to NRC, as appropriate. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity.

Not applicable. No records transfer or decommissioning has occurred as a result of this name change. No such transactions are required as all records remain under the control of personnel who maintained such records prior to the name change.

6. Confirm that the transferee will abide by all constraints, conditions, requirements, and commitments of the transferor or that the transferee will submit a complete description of the proposed licensed program.

Not applicable. There has been no transfer to a new party. The ownership of individual facilities, management team and personnel with duties related to the Materials License are entirely unchanged.
