
The following additional information is needed to review your request to terminate your NRC license.

1. Since your license also authorized you to perform leak test services for customers, please specify if you identified any leaking sealed sources and identify each radionuclide. If you never identified any leaking sources please state so.
2. Please provide information on the final disposition of contaminated leak test samples. If you never disposed of any contaminated leak test samples please state so.
3. Please provide a final survey of any reusable equipment, reusable protective equipment, tools, etc., that may have been contaminated during your leak testing activities. If you never had any contaminated reusable equipment, tools, etc., please state so.
4. Please clarify if you possess any radioactive sources used for operational check of your radiation survey instruments. If you still possess radioactive "operational check" sources please specify if they are exempt quantities and provide a copy of the labeling stating that these sources are exempt from licensing.

Please send a facsimile (630- 515-1078) of your response to the above within 7 days and state, Response to Control 579088. Please include a cover letter on company letterhead, date and sign (signed by an individual who is authorized to sign official documents on behalf of the licensee) with your response letter.
