Road 612, Lewiston, Michigan; W706 Boulevard Drive, St. Ignace, Michigan; and 10955 US 41, Rapid River, Michigan. Therefore, we have authorized the release of this location for unrestricted use.

You will be periodically inspected by NRC. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
