SUBJECT: ACCESS TO CLASSIFIED INFORMATION

Dear Mr. Miller:

Given the current cyber threat environment, the U.S. Nuclear Regulatory Commission (NRC) is considering taking steps to enhance cyber security at nuclear fuel cycle facilities. Consistent with this goal, the NRC is facilitating providing access to classified information to nuclear fuel cycle licensees on a voluntary basis.

Those licensees who would like to volunteer to obtain access to classified information may nominate up to five key licensee staff for personnel security clearances at each licensed location. Individuals nominated will go through a rigorous background check in order to be cleared. Additionally, each facility will undergo a Facility Security Clearance determination.

Access to classified information by individuals is governed by Title 10 of the Code of Federal Regulations (10 CFR) Part 25, Access Authorization. As part of the clearance process, each individual nominated will be required to complete the Standard Form 86 (SF 86), "Questionnaire for National Security Positions" electronically (on-line) through the Office of Personnel Management's (OPM) Electronic Questionnaires for Investigations Processing (e-QIP) system. E-QIP is part of an e-Government initiative sponsored by the OPM. It allows applicants to electronically enter, update, and release their personal investigative data over a secure internet connection to their employing agency for review and approval. Licensees will be expected to cover the initial and recurring costs of the individual clearances. Individual clearances must be updated every 10 years, specifically for "L" and every 5 years for "Q". Individuals must also execute the SF 312, "Classified Information Nondisclosure Agreement" (Enclosure 1), before the clearance, pending a successful background check, is granted. You should request an access authorization/clearance package from the NRC, Office of Administration, Division of Facilities and Security, Personnel Security Branch, for each person to be nominated. Fees are determined by the level of access authorization requested as prescribed by Title 10 of the Code of Federal Regulations (10 CFR Part 11.15 and 25.17) (L clearance is \$438 and Q clearance is \$6,240). This process may be performed concurrently with obtaining a Facility Security Request (FCL) but personnel security clearances will not be granted until an FCL is granted. All correspondence related to Part 25 should be communicated via one of the methods listed in 10 CFR 25.9.

Facility Security Clearances (FCL) requirements are governed by Title 10 of the *Code of Federal Regulations* (10 CFR) Part 95. In order for the NRC to make a Facility Security Clearance
