#### Dear Administrative Judges:

Pursuant to 10 C.F.R. §§ 2.1203 and 2.336 and as modified by the Atomic Safety and Licensing Board's ("Board") Memorandum and Order dated June 15, 2011 ("Order"), the staff of the Nuclear Regulatory Commission ("Staff") is providing an index identifying documents subject to disclosure under the Board's Order. On or about November 9, 2012, materials in the hearing file may be accessed through the Agencywide Documents Access and Management System ("ADAMS") and through the Electronic Hearing Docket ("EHD"). The index contains the ADAMS accession number, document date, and the document title.

Pursuant to 10 C.F.R. § 2.336(c), attached is the Affidavit of Samuel Cuadrado De Jesus, certifying that all relevant materials required by this section have been disclosed, and that the disclosures are accurate and complete as to documents identified by October 30, 2012.

The NRC Staff notes that it has made a good faith effort to identify and characterize all documents meeting the criteria of 10 C.F.R. § 2.336(b) and 10 C.F.R. § 2.1203 in this proceeding. In identifying these documents, the Staff does not concede their relevance to the license renewal issues to be decided in this proceeding.

The NRC Staff notes the Safety Evaluation Report ("SER") with open items was published July 31, 2012 and the Staff is currently expecting to publish the SER in January 2013. The Staff currently anticipates publication of the Draft Supplemental Environmental Impact Statement ("DSEIS") in February 2013. As previously noted, the Staff is currently unable to project a date for the publication of the Final SEIS at this time.
