On May 5, 2009, William B. JONES, Chief, Allegation Coordination and Enforcement Branch, U.S. Nuclear Regulatory Commission, Region IV (RIV), requested assistance from the Office of Investigations (OI), RIV, with two alleged interviews pertaining to corrective action documents associated with an October 2003 event that occurred at Callaway Plant (Callaway), Fulton, Missouri. JONES further requested that OI:RIV coordinate this staff assist with John KRAMER, Senior Resident Inspector, Division of Reactor Projects, RIV.

On May 7, 2009, (b)(7)(C) Callaway, was interviewed by OI:RIV and KRAMER in Columbia, Missouri (Exhibit 1). On May 14, 2009, (b)(7)(C) (b)(7)(C) Callaway, was interviewed by OI:RIV and KRAMER in (b)(7)(C) (b)(7)(C) (Exhibit 2).

No further action was requested by RIV staff; therefore, this assist to staff is hereby closed. Should any new information develop specific to conduct or actions involving willfulness or wrongdoing, OI:RIV will consider initiating supplementary investigative action as deemed appropriate.
