SUBJECT: CALVERT CLIFFS NUCLEAR POWER PLANT, UNIT 3 COMBINED LICENSE APPLICATION - SAFETY EVALUATION REPORT WITH OPEN ITEMS FOR CHAPTER 13, "CONDUCT OF OPERATIONS"

Dear Mr. Finley:

The U.S. Nuclear Regulatory Commission (NRC) staff is preparing a safety evaluation (SE) with open items (OIs) for each chapter of the Calvert Cliffs Nuclear Power Plant, Unit 3 Combined License Application (COLA) submitted by Calvert Cliffs 3 Nuclear Project and UniStar Nuclear Operating Services, LLC (UniStar) on July 13, 2007.

The staff's SE with OIs for Chapter 13, "Conduct of Operations," is being provided to the Advisory Committee on Reactor Safeguards (ACRS) subcommittee to support upcoming meetings of the ACRS subcommittee.

The enclosed SE with OIs is being provided only to UniStar for review of proprietary information pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) 2.390, "Public Inspections, Exemptions, Requests for Withholding." The staff concludes that the enclosed SE does not contain any information for which exemption from public disclosure has been sought or approved or any factual errors. However, the NRC will withhold the enclosed SE from public disclosure for ten working days from the date of this letter to allow you the opportunity to verify the staff's conclusion that the SE contains no such exempt information or any factual errors. If within that ten day period, you do not request that all or portions of the SE be withheld from public disclosure, the enclosure will be made available for public inspection through the NRC Public Document Room and the Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS) and placed on the NRC's public web page for this application.
