


The purpose of this modification is to (1) exercise option year 4, which increases the contract ceiling by \$190,157.95 from \$741,183.25 to \$931,341.00 (2) extend the period of performance through 6/30/2013 (3) change the NRC contracting officer. This contract is hereby modified as follows:

1. Section B.4 entitled: "Consideration and obligation – Task Orders (AUG 1989)

(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is **\$931,341.20**. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract.

2. Section F.3 entitled: "Duration of Contract Period (MAR 1987) Alternate 4 (JUN 1988)

The ordering period for this contract shall commence on **July 1, 2008** and will expire on **June 30, 2013**. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.) The term of this contract may be extended at the option of the Government for an additional **0** years.

3. Change the NRC Contracting Officer from Mike Mills to Shashi Malhotra (301)492-3604.

All other terms and conditions remain the same.
