Dear Mr. Gregg:

This refers to your August 30, 2012, letter transmitting a Decommissioning Plan (DP) for Aptuit, LLC (ML12248A095). We have completed our initial acceptance review of your DP and have determined that your submission is sufficiently complete for the U.S. Nuclear Regulatory Commission (NRC) to initiate our detailed technical review. Our goal is to commence our detailed technical review immediately and issue requests for additional information, if applicable, on or about January 2013. During the review period, we will contact you to clarify items discussed in the DP.

Our consideration of your amendment request to approve the DP will be published at a future date in the Federal Register, for a 60 day comment period, which will allow persons whose interest may be affected by the proceedings to submit comments and/or file a request for a hearing in accordance with Title 10 of the Code of Federal Regulations (CFR) Part 2, Subpart C.
