Kathryn, here's my thoughts on the memo:

- 1. I thought we decided to have Bill sign the letter out and have him certify in the text that we're OK. If so, I would change paragraph 2 first sentence to state "Based on a review of internal policies and controls associated with conference related activities and event, I certify that adequate controls are in place." That way we don't need any memo to files or other documentation for this response.
- 2. In paragraph 1, sentence 1, I would reference M-11-35 since that's the way OMB tracks responses. Suggested change is "In response to OMB Memorandum M-11-35 of September 21, 2011, "Eliminating...", I am providing...
- 3. Paragraph 3, second sentence change to "This amount equates to approximately one tenth percent of the NRC budget in each of the last three years."
- 4. Paragraph 3, last sentence change to "Attendance at NRC-sponsored conferences and meetings varied widely, with the largest conference numbering over 3000 staff, public and international attendees."
- 5. I would add a point of contact for followup in case someone at OMB wants to pick up the phone and discuss. I would like OCFO to be kept in the loop with any communications with Danny or his staff so could you add Milton to the POC list?
