Subject: Supplement to Administrative Amendment 36 to GESTAR II to Update the NEDO-33173 Supplement 4-A and NEDC-33173P-A References

This is a supplement to GESTAR II Administrative Amendment 36 to update references to Licensing Topical Reports (LTR): *Implementation of PRIME Models and Data in Downstream Methods*, NEDO-33173 Supplement 4-A (Reference 1), and *Applicability of GE Methods to Expanded Operating Domains*, NEDC-33173P-A (Reference 2).

Implementation of PRIME Models and Data in Downstream Methods, NEDO-33173 Supplement 4-A, Revision 1 (Reference 1) was revised to incorporate the NRC letter documenting the staff audit of the PRIME implementation in downstream analysis codes. The NRC staff determined that the PRIME models had been correctly implemented in accordance with the approved process described in NEDO-33173 Supplement 4. Because Applicability of GE Methods to Expanded Operating Domains, NEDC-33173P-A, includes the Safety Evaluation (SE) for each of the approved supplements, the same NRC letter was incorporated into the NEDC-33173P-A (Reference 2).

Section 2.4 in GESTAR II Main and Sections S.5.2 and S.6 in the US Supplement to GESTAR II are affected by this amendment. All changes are shown in revision mode to ease the review.

It is requested that the NRC review and approve this proposed supplement to Administrative Amendment 36 concurrent with the approval and issuance of the final Safety Evaluation (SE) for Administrative Amendment 36.
