Mr. Ryder:

Westinghouse Electric Company LLC (Westinghouse) requests a change to the SNM-1107 License Application for the Columbia Fuel Fabrication Facility. Chief Operating Officer Ric Pérez has elected to retire at the end of this year. With this pending retirement the company has chosen to eliminate the Chief Operating Officer position. Therefore, the Senior Vice President of Nuclear Fuel will now report directly to the President and Chief Executive Officer.

This revision consists of the page change enclosed and is submitted in accordance with the requirements outlined in 10 CFR 70.72 and in accordance with SNM-1107 License Application Authorization 12.1.1. The page changes enclosed modify the organizational structure to reflect the noted realignment.

The changes were reviewed by the Licensing group which determined there was no degradation of safety commitments, no impairment of Westinghouse's ability to meet applicable Federal Regulations and the changes do not conflict with any condition specifically required by the license.
