NRC Issues Amendment to the Vogtle Combined License

On November 6, 2012, the NRC issued License Amendment Number 3 to the Vogtle Units 3 and 4 Combined Licenses. This amendment authorizes Southern Nuclear Operating Company to revise the structural module shear stud size and spacing requirements included in the Updated Final Safety Analysis Report. The structural modules are comprised of concrete fill sandwiched between inner and outer steel plates. These modules are used inside containment (e.g., surrounding and providing support to the reactor vessel) as well as outside containment (e.g., for the spent fuel pool). Shear studs are provided to transfer shear forces between the concrete and steel plates and to ensure that the concrete and steel elements respond in a composite manner. Issuance of this amendment supports the Vogtle Unit 3 construction schedule.
