


The purpose of this modification is (1) to exercise Optional Task 6, (2) to increase the task order ceiling by \$97,170, from \$163,084 to \$260,254, and 3) to increase the task order funding by \$125,000, from \$40,000 to \$165,000.

Therefore, the following changes are made to the task order:

1. In accordance with FAR 52.217-8 OPTION TO EXTEND SERVICES, the option to perform Optional Task 6 is hereby exercised.
2. Section A.2, CONSIDERATION AND OBLIGATION—COST-PLUS-FIXED-FEE (AUG 2011) ALTERNATE 1 (AUG 2011), is hereby deleted in its entirety and replaced with the following:

A.2 CONSIDERATION AND OBLIGATION—COST-PLUS-FIXED-FEE (AUG 2011) ALTERNATE 1 (AUG 2011)

(a) The total estimated cost to the Government for full performance of this contract is \$260,254, of which the sum of _____ represents the estimated reimbursable costs, and of which _____ represents the fixed-fee. This amount will increase as follows should the optional tasks be exercised:
