

Attached is a report from the General Services Administration from Jun 1962 that indicates that close to 905 of the land at Beltsville is considered exclusive federal jurisdiction. The Real Property Specialists from Beltsville indicated that the initial Congressional enabling legislature from the 1930's for the acquisition of this property is where the exclusive federal jurisdiction designation can be found. The Real Property Specialists use this report to demonstrate evidence of exclusive federal jurisdiction for the Beltsville Agricultural Research Center. Please let me know if you have any questions.
