AN ORDINANCE OF LEVY COUNTY, FLORIDA, RELATING TO SPECIAL EVENT PERMITS; PROVIDING THAT THE LEVY COUNTY CODE BE AMENDED BY AMENDING SECTIONS 50-1, 50-352, 50-676, 50-763, AND 2-140 OF SUCH CODE AND DELETING SECTIONS 10-31 THROUGH 10-54 AND 42-1 OF SUCH CODE; PROVIDING THAT THE LEVY COUNTY CODE BE AMENDED BY ADDING A NEW SECTION 50-766; PROVIDING FOR DEFINITION OF SPECIAL EVENTS AND RELATED TERMS; PROVIDING FOR SPECIAL EVENT PERMIT APPLICATIONS AND RELATED PROCEDURES FOR REVIEW, CONSIDERATION, AND ISSUANCE OF SUCH PERMITS; PROVIDING FOR SEVERABILITY; PROVIDING A REPEALING CLAUSE; AND PROVIDING AN EFFECTIVE DATE.
