Thanks for the reports. Based on the limited availability of participants on our end, your schedule for tomorrow afternoon, and the conflict with the DCWG that would exist on 12/5/12, I would like to make an alternate proposal for upcoming "bi-weekly" calls. I would like to propose that we cancel the call for tomorrow, and have a call on 11/28 instead, and then 2 wks after that on 12/12. Then I would propose that we resume the bi-weekly meetings again on 1/9/13. I'm thinking the 9th instead of the 2nd since the 2nd would be the first day back from the holidays and everyone will be busy just trying to get caught up.
