**SUMMARY**

SUBJECT: Request for NRC approval of transfer of control of NRC Material License No. 13-32556-01 from Premier Diagnostic Imaging, LLC, to Terre Haute Regional Hospital.

We have reviewed your letter dated August 24, 2012, requesting NRC approval of the transfer of control of NRC Material License No. 13-32556-01 from Premier Diagnostic Imaging, LLC, to Terre Haute Regional Hospital. We are unable to complete this action until we have received information regarding the following:

- (1) Provide a complete description of the transaction (transfer of stocks or assets, or merger) transferring control of ownership of Premier Diagnostic Imaging, LLC (PDI) to Terre Haute Regional Hospital. Indicate whether the name has changed and include the new name.
- (2) Submit a signed statement from the owner of PDI, (or another senior manager from PDI), agreeing to the transfer of control of this license to Terre Haute Regional Hospital.
- (3) Describe in greater detail the current status of control of licensed material at the PDI facility, including the secure storage of sealed calibration sources. Confirm whether source inventories and surveys have been conducted since the last time radioactive materials were used, and provide the results of such inventories and surveys.
- (4) The requesting letter dated August 24, 2012, requests that authorized users (AUs) on Terre Haute Regional Hospital's License No. 13-09649-02, are to be added to the PDI license. The letter dated June 4, 2012, signed by the CEO of Terre Haute Regional Hospital specifies that the AUs on PDI license are to remain the same. Please clarify this discrepancy. If AUs currently listed on Terre Haute Regional Hospital are to be added to the PDI license, please state whether the current AUs on the PDI license are to be remain or be removed.

We have requested that you submit your responses to the referenced items above via facsimile to (630) 515-1078 no later than Friday, November 2, 2012. In your response, please reference Control No. 578159.

## Information Needed for Transfer of Control

The following information is taken from NUREG-1556, Volume 15, "Consolidated Guidance About Materials Licenses: Program-Specific Guidance About Changes of Control and About Bankruptcy Involving Byproduct, Source, or Special Nuclear Material Licenses."

### Definitions

**Control:** Control of a license is in the hands of the person or persons who are empowered to decide when and how that license will be used. That control is to be found in the person or persons who, because of ownership or authority explicitly delegated by the owners, possess the power to determine corporate policy and thus the direction of the activities under the license.

**Transferee:** A transferee is an entity that proposes to purchase or otherwise gain control of an NRC-licensed operation.

**Transferor:** A transferor is an NRC licensee selling or otherwise giving up control of a licensed operation.

Licensees must provide full information and obtain NRC's *prior written consent* before transferring control of the license. Provide the following information concerning changes of control by the applicant (transferor and/or transferee, as appropriate). If any items are not applicable, so state.

1.  Provide a complete description of the transaction (transfer of stocks or assets, or merger). Indicate whether the name has changed and include the new name. Include the name and telephone number of a licensee contact whom NRC may contact if more information is needed.
2.  Describe any changes in personnel or duties that relate to the licensed program. Include training and experience for new personnel.
3.  Describe any changes in the organization, location, facilities, equipment, or procedures that relate to the licensed program.
4.  Describe the status of the surveillance program (surveys, wipe tests, quality control) at the present time and the expected status at the time that control is to be transferred.
5.  Confirm that all records concerning the safe and effective decommissioning of the facility will be transferred to the transferee or to NRC, as appropriate. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity.
6.  Confirm that the transferee will abide by all constraints, conditions, requirements, and commitments of the transferor or that the transferee will submit a complete description of the proposed licensed program.
