By letter dated November 24, 2008 (Agencywide Documents Access and Management System Accession No. ML083460059), Westinghouse submitted for U.S. Nuclear Regulatory Commission (NRC) staff review Topical Report (TR) WCAP-12610-P-A & CENPD-404-P-A, Addendum 2/WCAP-14342-A & CENPD-404-NP-A, Addendum 2, "Westinghouse Clad Corrosion Model For ZIRLO™ and Optimized ZIRLO™." Enclosed for Westinghouse review and comment is a copy of the NRC staff's draft safety evaluation (SE) for the TR WCAP-12472-P/WCAP-12472-NP, Addendum 4.
