Purpose of Meeting: A management meeting will be held to discuss the actions taken and

planned by GIS to prevent recurrence associated with an over-exposure event that occurred during a source reload of a self-shielded irradiator in an Agreement State on October 8, 2011. Based on information gathered during accompaniments with the Agreement State inspectors, the NRC became concerned about the adequacy of the safety and radiological controls implemented by GIS during the event and issued GIS a Confirmatory Action Letter (CAL). GIS agreed not to perform source reloads and source exchanges in NRC jurisdiction until actions taken in

the CAL were completed.
