You recently submitted a Decommissioning Funding Plan (DFP) and self-guarantee (SG) dated February 20, 2012, to demonstrate your financial assurance for decommissioning activities required by your NRC license. These documents are currently under review by our staff. Additionally, you previously provided a DFP dated April 10, 2007, and SG dated February 9, 2007, and a DFP dated March 10, 2010 and SG dated March 8, 2010, to the NRC, which we have not taken any final action on. Since you provided revised financial assurance dated February 20, 2012, and these documents are currently under review, we have cancelled the previously submitted documents and are returning them to you.
