Insert the following at the end of the second paragraph in DCD Subsection 5.3.1.6.1. "Test specimens are taken from material used for the reactor vessel beltline."

STD SUP 5.3(2)

Insert the following after the first sentence in the fifth paragraph in DCD Subsection 5.3.1.6.1. "The capsules are sealed in an inert environment."
