**Purpose**

The purpose of this letter is to submit to the U.S. Nuclear Regulatory Commission (NRC) the monthly Security-related Logs for USEC Inc. (USEC).

**Background**

In accordance with 10 *Code of Federal Regulations* (CFR) 95.57(b), USEC is required to notify the NRC of the monthly Security Incident Log entries made for the American Centrifuge Plant (ACP)/Lead Cascade Facility, USEC headquarters (HQ) and for USEC's strategic suppliers who implement a NRC-approved security program. Also in accordance with the *Standard Practice Procedures Plan* (SPPP), *Standard Format And Common Set Of Requirements For The Protection of Classified Matter For USEC Inc. And Its Limited Liability Companies Regulated by the U.S. Nuclear Regulatory Commission*, USEC is required to notify the NRC of the monthly SPPP Impact Measurement Index (IMI) Incidents of Security Concern Log entries made for the American Centrifuge Project. This CFR requirement and/or SPPP requirement is contained within these NRC-approved security programs.
