On March 12, 2012, the NRC issued Reference 1 to all power reactor licensees. Enclosure 4 of the referenced letter contains specific requested actions, requested information, and required responses associated with Recommendation 2.3 for flooding walkdowns. Entergy Operations, Inc. (Entergy) confirmed in Reference 2 that it would use the flooding walkdown procedure (Nuclear Energy Institute 12-07, *Guidelines for Performing Verification Walkdowns of Plant Flood Protection Features*) as endorsed by the NRC as the basis to conduct the walkdowns and develop the needed information at Arkansas Nuclear One, Unit-2 (ANO-2).

Pursuant to Required Response 2 of Reference 1, Enclosure 4, Entergy is providing the Flooding Walkdown Report for ANO-2 in Attachment 1.
