discussed in Section 3.9.3 of the Final Safety Analysis Report (FSAR), as submitted in Part 2 of the Calvert Cliffs Nuclear Power Plant (CCNPP) Unit 3 Combined License Application (COLA), Revision 8.

Reference 4 indicated that a response to RAIs 362, 363, and 364 would be provided to the NRC by December 6, 2012.

UniStar Nuclear Energy requires additional time to finalize the responses to RAI 362, Question 03.09.03-2, RAI 363, Question 03.09.03-3, and RAI 364, Question 03.09.03-4. Responses to these questions will be provided to the NRC by April 15, 2013. These responses are dependent on the AREVA final response to their RAI 547, regarding Combined License (COL) Items, which is pending NRC comments on the RAI 547 draft response.
