SUBJECT: TERMINATION OF NRC RADIOACTIVE MATERIALS LICENSE

By NRC Form 314 dated November 29, 2012, you informed the U.S. Nuclear Regulatory Commission (NRC) that Helena Sand & Gravel, Inc. wished to terminate NRC radioactive materials license number 25-29363-01. The letter stated that all radioactive material had been transferred to another NRC licensed entity.

The NRC staff has reviewed the supporting documentation provided by you and docketed under mail control 579196 and 579377. The leak test results document that there was no leakage of radioactive material from the sealed sources. Based on this information and a review of your historical file, the staff concluded that all licensable radioactive material has been removed from your facilities located at 2930 Canyon Ferry Road, Helena, Montana, and 759 Highway 93 North, Hamilton, Montana. These facilities are suitable for unrestricted use in accordance with 10 CFR 20.1402, "Radiological Criteria for Unrestricted Use." No further remediation or actions with respect to NRC regulated material is required.

Enclosed is Amendment No. 01 to NRC License No. 25-29363-01 authorizing license termination. An environmental assessment for this action is not required since this action is categorically excluded under 10 CFR 51.22(c)(20)(ii).
