PURPOSE: To seek stakeholder input regarding the financial qualification requirements of 10 CFR 50.33(f) as applied to merchant plant combined license applicants. The NRC is considering a full range of alternatives regarding financial qualifications (FQ) for merchant plant COL applicants. This meeting will focus on the industry-proposed alternative of using license conditions to meet FQ requirements. License conditions have been proposed by the Nuclear Energy Institute and other interested stakeholders.

CATEGORY 2:* This is a Category 2 Meeting. This meeting is intended to include representatives from the regulated industry, applicants, and licensees, to focus discussion of the merchant plant COL applicant financial qualification process.
