Dear Mr. Linder:

On October 24, 2012, during routine 20-year Mechanical Integrity Testing (MIT), well number P-260 in Mine Unit 3, Wellhouse 8 failed the MIT criteria. Using isolation techniques, it was determined that the failure is the casing joint at the 680-foot level. Lindsey Phillips, of the NDEQ field office in Chadron and Ron Burrows, NRC Project Manager were notified concerning this well on October 25, 2012.

Following isolation of the problem, a 10 foot sleeve was set using a drilling rig. The top of the sleeve is located at 675 feet and extends to 685 feet.

The well was then re-integrity tested on November 19, 2012 to check the entire well interval from 693 feet to the surface. A copy of the successful MIT is enclosed.
