Steve,

During this week's public meeting between the NRC staff and the US-APWR DCWG, we discussed the path forward regarding the application of GDC-5 to the CPNPP Units 3 and 4 switching station. Here is my understanding based on the meeting:

- A conference call will be arranged between Luminant and the NRC staff during which the NRC staff will present its position (Luminant to provide any specific questions to be addressed prior to the call)
- If requested by Luminant, the NRC staff will provide a written position to document their position
- Luminant will assess the position and determine subsequent actions including a possible appeal to NRC management

As I mentioned in the meeting, Luminant will prepare a list of specific aspects of the issue that we would like to discuss during the conference call (such as which SSCs in the switching station are considered "important to safety" and how CPNPP Units 3 and 4 are unique compared to other COL/COLAs and the operating plants). I am still hoping that we can find a position which is satisfactory to all without pursuing an appeal.

In order to allow the Luminant sufficient time to prepare its list of topics and to allow the NRC staff sufficient time to prepare for the call, I suggest that we plan for a call the week of January 21, 2013. Please consider this proposal and let me know what dates and times might work for the NRS staff.
