This letter documents that on December 16 and 17, Dennis Lawyer and Orysia Masnyk Bailey of this office, completed a safety and security inspection of your manufacturing and distribution licensed program at the above listed address. One or more safety or security violation(s) were identified. Nordion (Canada) Inc. took immediate corrective actions to address any security related vulnerabilities. The results of that inspection were included in a report that was forwarded to you by letter dated December 17, 2012.
