Dear Mr. Stout:

This refers to the administrative amendment to your NRC license. This administrative amendment was discussed with you on December 12 and 14, 2012.

Enclosed with this letter is the amended license. License Condition 12.A was modified to clearly state that licensed activities can only be performed in the physical presence of your two Authorized Users. In addition, License Condition 16 was added to require you to notify the NRC, in writing, at least 14 days prior to all source reloads and source exchanges. This latter special license condition was coordinated with our program office, as well as, with the Commonwealth of Pennsylvania.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
