Please find attached the Squaxin Island Tribe's request for consultation with three federal agencies with regard to the Tribe's lands and Treaty rights. To summarize, the Tribe seeks advance notice when the railroad that crosses the Tribe's Reservation is carrying nuclear materials, which may increase due to the Navy's new wharf. The same railroad also uses culverts that block fish passage. The Tribe seeks to resolve these issues.
