

The purpose of this modification is to (1) exercise the first option year in accordance with FAR clause 52.217-19, entitled "Option to Extend the Term of the Contract, thereby extending the contract period of performance through 2/28/2014, and (2) provide funding in the amount of \$21,000.00 thereby increasing the obligation and ceiling amount from \$21,000.00 to \$42,000.00.

Accordingly, the following highlighted changes are hereby made:

A.1 CONSIDERATION AND OBLIGATION—FIRM FIXED PRICE (JUNE 1988)

The total amount of the firm fixed price portion of this contract is \$42,000.00, and this amount of fully-funded.

A.2 PERIOD OF PERFORMANCE (AUG 1987)

This contract shall commence on 3/1/2013 and will expire on 2/28/2014. The term of this contract may be extended at the option of the Government for an additional two-one year period.

Option Period 1: 3/1/2013-2/28/2014 is hereby exercised.

A.6 52.232-19 AVAILABILITY OF FUNDS FOR THE NEXT FISCAL YEAR (APR 1984)

Funds are not presently available for performance under this contract beyond 2/28/2014. The Government's obligation for performance of this contract beyond that date is contingent upon the availability of appropriated funds from which payment for contract purposes can be made. No legal liability on the part of the Government for any payment may arise for performance under this contract beyond 2/28/2014, until funds are made available to the Contracting Officer for performance and until the Contractor receives notice of availability, to be confirmed in writing by the Contracting Officer

A.7 52.217-9 OPTION TO EXTEND THE TERM OF THE CONTRACT (MAR 2000)

(a) The Government may extend the term of this contract by written notice to the Contractor within 60; provided that the Government gives the Contractor a preliminary written notice of its intent to extend at least 30 days before the contract expires. The preliminary notice does not commit the Government to an extension.

(b) If the Government exercises this option, the extended contract shall be considered to include this option clause.

(c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed 2/28/2016.
