2) Physical Description

This shipment will consist of 722 drums of Uranium Ore Concentrate (U-308) in 15 x 20' ocean containers. The total weight of the shipment is 264,973.749 kg of U-308.

3) Transportation and Route Schedule

The vessel sails from Adelaide on August 13, 2012. The ocean transportation from Adelaide to Tacoma, WA USA will be the responsibility of Hapag Lloyd. The vessel will unload at Tacoma, WA USA on or about September 07, 2012. Shipment will be reloaded onto another Hapag Lloyd vessel at Tacoma, WA USA on or about September 09, 2012. The inland transportation at the terminal in Tacoma, WA will be the responsibility of Hapag Lloyd.
